- Member of the Northern Ireland Assembly
- Member of the UK Parliament representing Northern Ireland
- County or City Councillor
- Senior Civil or Public Servant
- Other suitably qualified individuals

The Rules of AGI, appended to AGI's Constitution, require all applicants to submit the names of two referees of standing as to the applicant's character. In addition, the Council of AGI requires that all applicants provide the name of a third referee, a current or former client, who can attest to the applicant's competence in the field of genealogy.
